ORDER

As per University Orders read (1) to (3) above, district wise Examination Vigilance Squads were constituted to visit the Examination Centres of the University in Wayanad, Kozhikode, Palakkad, Malappuram and Thrissur Districts, to examine and ensure that the procedures followed in the conduct of examinations, during the hours of the examination and hours before and after the examination fixed for commencement and completion of the examination, keeping and maintenance of accounts of the examination related materials etc. are in accordance with the rules, regulations and directions issued by the University from time to time. The Examination Vigilance Squads were also entrusted to report malpractice, if any, noticed, to the Controller of Examinations with proper acknowledgement by the Chief Superintendent / Additional Chief Superintendent of the Examination Centres.

As per University Order read (1) the term of the Examination Vigilance Squad of each district is for an academic year, beginning from the month of June to the end of May of each Calendar Year and the maximum term of extension of the Examination Vigilance Squads is two consecutive academic years.

As per University Order read (2), a member of the Syndicate will be the General Convenor to co-ordinate the work of the Examination Vigilance Squads of each district.

On completion of the Academic Year 2022-23, the Vice Chancellor, vide paper read (4) above, has ordered to extend the term of the Examination Vigilance Squads, constituted vide University Orders read (1) to (3) above, up to May 2024. It has also been ordered to appoint Dr. Vasumathi T, Member, Syndicate and Assistant Professor, Department of Education, University of Calicut, as General Convenor of the Examination Vigilance Squads, in the place of Lt.Dr.Rijulal.G, former member of Syndicate, and to report the matter to the Standing Committee of the Syndicate on Examinations.

In the light of the above orders, sanction is accorded for the following :

1. The term of the Examination Vigilance Squads, constituted vide University Orders read (1) to (3) above, is extended up to May 2024 (i.e up to 31.05.2024).
2. Dr. Vasumathi T., Member, Syndicate and Assistant Professor, Department of Education, University of Calicut, is appointed as the General Convenor of the Examination Vigilance Squads up to May 2024.
3. The expenditure towards payment of remuneration to the Examination Vigilance Squads will

be met from the Head of Account Part 1 Non Plan 06-2032-01 conduct of examinations and expenditure towards payment of vehicle charges of Examination Vigilance Squads will be met from the Head of Account Part 1 Non Plan 06-2021-01 Hire charges of vehicles, of the respective year's budget estimate.

4. The matter of extension of the term of the Examination Vigilance Squads and appointment of Dr. Vasumathi T., Member, Syndicate and Assistant Professor, Department of Education, University of Calicut, as the General Convenor of the Examination Vigilance Squads, will be reported to the Standing Committee of the Syndicate on Examinations.
